The National Works Agency (NWA) invites sealed bids from eligible and suitably qualified contractors for the procurement of **ROAD REHABILITATION - CAYMANAS GARDEN (SITE D), ST. CATHERINE / NATIONAL HOUSING TRUST FY 2024/2025**.

Scope of Works: The works consist of but is not limited to Demolition, Site Clearance & Drain Cleaning, Earthworks, Pavement Works including scarifying, 150mm thick base course, prime coat application, asphaltic concrete overlay (38mm thick) and asphaltic concrete regulation, Concrete Works to include reinforced concrete 21Mpa, formwork and supports, BRC fabric mesh, and Ancillary Road Works.
