The Kingston & St. Andrew Municipal Corporation (KSAMC) invites sealed bids from eligible and suitably qualified suppliers for the procurement of the **Road Rehabilitation of a section of Wickie Wackie**.

**Scope of Works:** The objective of this project is to do Road Rehabilitation of a section of Wickie Wackie with asphaltic concrete 38mm thick. Preparatory works include scarifying of existing surface and carting away of spoils. The construction of a new limestone base grade, wet and compact to receive asphaltic concrete as directed.

**Objective of the Consultancy:** The Senior Information Technology Specialist is required to oversee, coordinate, and manage the development of the Social Protection Information System and the Labour Market Information System for the delivery of key services in the Ministry of Labour & Social Security.

Experience in public sector service automation and familiarity with e-Government solutions (local or international) are desirable. **(Weight – 25%)**
4. Extensive experience in implementing information systems, with special emphasis on organizational change associated with the implementation of such systems, including knowledge of methodologies and standards for the implementation of information systems **(Weight – 20%)**
5. Experience using a variety of systems analysis methods and techniques (methodologies for developing information systems, data collection techniques, visual modelling languages, etc.). Good understanding of different software and database system architecture options (including open-source architecture). **(Weight – 10%)**
6. Experience with different platforms, tools, and operating systems. Broad knowledge of web applications **(Weight – 10%)**.
