The Houses of Parliament consists of the Upper and Lower Houses. The Senate, which is the Upper House, is the direct successor of a pre-Independence body known as the "Legislative Council" and comprises of 21 senators appointed by the Governor-General: thirteen on the advice of the Prime Minister and eight on the advice of the Leader of the Opposition.

The Houses of Parliament now invites eligible and qualified firms/individual to submit their full curricula vitae for the Consultancy Services for stenography services for a period of six (6) months.
