The Western Regional Health Authority (WRHA) now invites eligible and qualified bidders to participate in the **Construction of Medical Waste Holding Area at the Falmouth Public General Hospital**.

Bidding will be conducted in accordance with the National Competitive Bidding (NCB) Procedures as specified in the Public Procurement Act, 2015 and Public Procurement Regulations 2018.

Bidders must submit the following with their bids at the time of bid opening:

#### Eligibility Requirements for Local Suppliers

- Local Contractors must be registered with Public Procurement Commission (PPC), formerly known as the National Contracts Commission (NCC), in Building Construction category at Grade 3 or above.
- Present a valid copy of the company Tax Compliance Letter (TCC/TCL). The letter must be supported with information pertaining to the expiry date of TCC.

#### Mandatory Requirements

- Completed and Signed Bidders Information Form
- Completed, Signed and Stamped Bill Of Quantities
- Site Visit.

**\*\*Non-compliance with all or any of the criteria above will result in an automatic disqualification of tender.\*\***
