The National Works Agency (NWA) invites sealed bids from eligible and suitably qualified contractors for the procurement of **ROAD REHABILITATION – OLYMPIC WAY PHASE 2 (BAY FARM TO HAGLEY PARK ROAD), ST. ANDREW/ MINISTRY OF ECONOMIC GROWTH AND JOB CREATION / MAINTENANCE OF SECONDARY ROADS F/Y 2024/2025**.

Scope of Works: The works consists of but is not limited to Demolition & Site Clearance, Earthworks, Pavement Works including 150mm base course and 38mm thick asphaltic concrete overlay and asphaltic concrete patching, Ancillary Road Works including 20 MPa reinforced concrete (100mm thick), fabric reinforcement, mass concrete, kerb and channel, formwork and supports, and Traffic Facilities.
