MORAVIA POTABLE WATER TREATMENT PLANT BRIDGE REPLACEMENT- CHRISTIANA/ SPALDINGS WATER SUPPLY SCHEME, EXTENSION, REHABILITATION AND UPGRADING PROJECT, MANCHESTER – RETENDERED

Procuring Entity: The National Water Commission

Description of Service: The works comprise the complete construction of a pre-cast concrete bridge (approximately 12m x 5m x 6m) to include marl ramp 4m long and 5m3 sidewalk cast in-situ. To the Moravia Potable Water Treatment Plant, together with the provision for numerous appurtenances of stated Contract Specification and Conditions.

Eligibility Requirements:

Tenderers must submit:

- A valid Tax Compliance Certificate (TCC)/Tax Compliance Letter (TCL) at the bid submission deadline
- A valid registration certificate from the Public Procurement Commission, valid at the bid submission deadline in the following classification:
  - Bridge Construction–Grade 2 minimum
  - Civil Engineering–Grade 2 minimum

- Completed, signed and sealed form of tender
- Bid security in the correct amount and form
- A Power of Attorney (POA) document is required if the Company's bid is not signed by a Director or Chief Executive Officer of the company.

Additional requirements are outlined in the Criteria used for evaluation in the Bidding Document.

Availability of Bid Document and Bid Submission: This is an online tender where tender documents, clarifications and bids will only be made available and accepted via the Government of Jamaica Electronic Procurement Portal – GOJEP ([www.gojep.gov.jm](http://www.gojep.gov.jm)). - Clarification period – no later than 7 working days (**Monday, May 19, 2025**) ) before bid submission deadline.
