The Health Promotion Strategic Plan for NCDs in Jamaica 2020-2025 works towards the fulfilment of the first programme priority in the 2013 National Strategic & Action Plan for NCDs: risk factor reduction through health promotion. It will fulfil the Ministry of Health & Wellness' (MOHW) Vision 2030 commitment to develop a comprehensive plan for healthy lifestyles promotion.

The MOHW's 10-year strategic plan, Vision 2030, emphasizes the importance of addressing Social Determinants of Health (SDH) and health inequities. The health promotion strategic plan for NCDs utilizes theoretical approaches that align with Vision 2030 to address SDH and promote healthy behaviours in "the conditions in which people are born, grow, live, work and age."

#### OBJECTIVE OF THE CONSULTANCY

To develop communication collateral for the Social Marketing Campaign

#### 1. SCOPE OF WORK

In undertaking this assignment, the consultant is required to:

- Create an implementation plan and schedule for the development of communication collateral for work, school, and communities.
- Create communication collateral that should include but not be limited to videos, social media cards, television, radio and print ads, infographics as well as artwork for promotional items.
- Collaborate with event planners and programme officers for each of the settings to fine-tune content and format of the communication collateral.
- Provide monthly progress report on implementation activities.

#### MINIMUM REQUIREMENTS

- Qualification and Experience

The selected firm should have at least five (5) years of expertise in communication (social marketing and mass media). **Demonstrated** experience for at least 2 years in the development of communication collateral for various target groups.

- A Bachelor of Arts in Communication, Health Promotion, Marketing, or related discipline with at least 5 years' experience in Communication
