The contract will be executed under a Lump Sum Turnkey (LSTK) Design-Build Arrangement and includes:

- Submission and acquisition of all regulatory approvals
- Part B: Civil Works Implementation

- Furnishing and equipping of facilities
- Testing, commissioning, as-built drawings, training, and maintenance plans
