Description of Service: The Supply & Delivery Supply and Delivery of Approximately 2.5km of 200mm (8") and 0.2km of 100mm (4") Nom. Diameter Ductile Iron Pipes to include 2.5km of 2" Nominal Bore x 6m Threaded Schedule 40 Galvanized Iron Pipes and Associated Appurtenances.

Eligibility Requirements
