The Post and Telecommunications Department c/o The Postmaster General/CEO, invites bids from suitably qualified contractors for the provision of renovation works at the Montego Bay #2 Post Office.

Bidding will be conducted in accordance with the current Guidelines stipulated in the Government of Jamaica Public Procurement Act, 2015.

SCOPE OF WORK:

Works comprise of but are not limited to demolition and preparatory works, dry wall partition, wall and floor finish installation, fabrication and installation of anodized aluminium windows and doors, fabrication and installation of glass partition, painting, plumbing, electrical and fire alarm system installation.
