The Government of Jamaica has received financing from the World Bank towards the cost of the Jamaica Education Project (JEP), and intends to apply part of the proceeds for consulting services for **Probity Assurance Auditor**.

The Ministry of Education, Skills, Youth & Information now invites eligible individuals ("Consultants") to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The shortlisting criteria are Qualification and Experience (See TOR, Section 8).

Objectives of the Consultancy

The Probity Assurance Auditor will provide probity assurance services to ensure that the procurement activity under the Jamaica Education Project for the design-build contract for the STEM school in Minard, St. Ann, is conducted with integrity, fairness, transparency, and in compliance with GOJ procurement policies and the World Bank Procurement Regulations.

Duration of Consultancy

The engagement will be fifteen (15) person days over seven (7) months for the duration of the procurement process, from pre-tender preparation to contract award.

Selection Method

Individual Consultant Selection method as set out in the World Bank's Procurement Regulations. Firms may provide qualified individual Consultant for the assignment. In such cases, the individual shall be fully capable of carrying out the assignment and the evaluation shall be based on the relevant qualifications and experience of the individual Consultant (not the firm).

The attention of interested Consultants is drawn to Section III, paragraphs, 3.14, 3.16, and 3.17 of the World Bank's "Procurement Regulations for IPF Borrowers" September 2023 ("Procurement Regulations"), setting forth the World Bank's policy on conflict of interest.
