- In accordance with the Public Procurement Regulation 17, the Consultant/Firm and any named subcontractor shall have to demonstrate that they have paid all taxes, duties, fees and other impositions as may be levied in Jamaica as part of their bid. Proof of Tax Compliance is a valid copy of the Tax Compliance Letter (TCL).
- Public Procurement Commission (PPC) Registration in the category Information Technical Services, Computers and related services
