#### Eligibility Criteria

Bidders must submit the following with their proposals:

1. **Valid Tax Compliance Letter (TCL) or Tax Compliance Certificate (TCC)**

**Bidders who do not possess a valid TCL/TCC or current registration at the time of bid submission deadline will be automatically rejected.**

#### Procurement Methodology

Bidding will be conducted through the **National Competitive Bidding (NCB)** Procedures stipulated in the Government of Jamaica Public Procurement Act, 2015 and Regulations, 2018.

#### Clarifications

All clarifications may be requested no later than five (5) days prior (**July 05, 2025**) to the submission deadline. All clarifications shall be made through the e-GP system.

#### Bid Validity

Bids are valid for a period of **120 calendar days** after the Bid Closing Date or **November 07, 2025**.

#### Availability of Documents

Bidding documents will be available on the GOJEP for download on **June 10, 2025**.

#### Pre-Bidders Meeting

Pre-bidders meeting will be held **on June 24, 2025 at 11:00 a.m.** at TPDCo's Head Office: 64-70 Knutsford Boulevard.

#### Deadline for Submission of Proposals

Proposals must be submitted on or before **11:00 a.m. on July 10, 2025 in keeping with the procedures outlined in the Quick Guide for Suppliers**. Any proposal received after the closing time for submission of proposals shall be returned unopened.

#### Tender Opening

The proposals will be opened electronically on the GOJEP at **11:15 a.m. on July 10, 2025**.
