The Ministry of Local Government and Community Development now invites bids from eligible and qualified bidders for the **Preventative Maintenance Contract for Air-Conditioning Units**, Exhaust and Fresh Air Intake Systems and Extractor Fans for Three (3) Years 2025 - 2028.
