The Government of Jamaica/Ministry of Health & Wellness, through the Health Systems Strengthening for the Prevention and Care Management of Non-Communicable Diseases Programme (HSSP), intends to undertake consulting services for contract award for a Project Lead to oversee the execution of three (3) health facilities: Ocho Rios and Brown's Town Health Centres and May Pen Hospital. The contract duration period is Twenty-Four (24) months.

OBJECTIVES OF THE CONSULTANCY

The Project Lead will oversee the execution phase of the construction and renovation of the three (3) health facilities—May Pen Hospital, Brown's Town Health Centre and Ocho Rios Health Centre. This role entails ensuring the project's' timely, cost-effective, and high-quality completion. The Project Lead will supervise and coordinate the activities of the contractors, ensuring compliance with design specifications, schedules, budgets and the relevant Environmental, Social, Health and Safety (ESHS) standards and the Works Contractors Code of Conduct requirements specified in the Works Contracts.

QUALIFICATION AND EXPERIENCE

Interested Consultants should provide information demonstrating that they have the required qualifications and experience to perform the Services. The consultant should satisfy the following requirements:

 Degree in Civil Engineering, Construction Management, Architecture, or a related field.

(ii) Minimum five (5) years of experience in project management, specifically in infrastructure and health sector projects.

(iii) Proven experience in monitoring and supervising construction works, including managing contractors and site teams.

(iv) Proficiency in project management tools and software

(v) A valid Tax Compliance Certificate (TCC) or Tax Compliance Letter (TCL) is required.
