- Demolish and rebuild restroom manholes and sand filters
- Install all associated plumbing for a new grease trap
- Construct a lift station and soakaway
- Install electrical upgrades to main control panel
- Install submersible pumps in lift station
- Temporarily relocate gas cylinder and pipes and wooden fence enclosure during construction and return to original area
- Renovate plumbing in restroom with installation of new water closets, handwashing troughs.
