Scope: Construction of a 1,900 square foot woodwork shop for the Portland Bee Farmers' Association – Woodwork Shop Project. The facility will have a grid tied PV system, use rainwater harvesting and include an office, restroom, storage area, parking area and delivery space.

Works Period: Five (5) months
