## RE-TENDER SUPPLY & INSTALLATION OF SOLAR POWER GENERATION SYSTEM Anchovy Police Station - St. James

**Procuring Entity:** National Housing Trust

**Scope:** The successful supplier will be required to:

- provide an electrical load evaluation of the site to determine power demand at full load during peak and off-peak hours
- design, supply, install, and commission a complete solar power generation system inclusive of lithium battery back-up to power the following:
  - » full load of the site between 50% and 100% of the total battery capacity
  - » critical loads between 30% and 50% of the total battery capacity. During this period non-critical load should be operating exclusively on the supply from the Jamaica Public Services Company Limited (JPSCo)
- complete the design/application process and obtain a net billing license from the JPSCo
- submit schematic designs and as-built drawings for the installed solar power generation system.

The solar power generation system should also switch to the JPSCo's electrical system during none to low generation periods.
