ELIGIBILITY OF CONTRACTORS

To be considered eligible, at the time of tender opening, your tender must include the following:

Local Bidders

- Copy of a valid Tax Compliance Certificate at the time of Bid Submission

International Bidders

- International Bidders are not required to submit a TCC at the time of bid submission. However, where any aspect of the contract will be performed in Jamaica, the successful Bidder is required to provide the UHWI with a valid TCC at the time of contract award.

Non-compliance with all or any of the criteria above will result in automatic disqualification of tender.

PROCUREMENT METHODOLOGY

International Competitive Bidding (ICB)

SCOPE OF WORK

The audit shall be conducted in accordance with International Standards on Auditing (ISAs) and will include examining financial records, reviewing internal controls, verifying compliance with donor and regulatory requirements, and assessing procurement for value for money. The auditor shall also detect any fraud or irregularities, meet with management, and prepare a Management Letter with findings and recommendations.

SOLAR POWER GENERATION SYSTEM

Little London Police Station - Westmoreland

Procuring Entity: National Housing Trust

Scope: The successful supplier will be required to:

- provide an electrical load evaluation of the site to determine power demand at full load during peak and off-peak hours
- design, supply, install, and commission a complete solar power generation system inclusive of lithium battery back-up to power the following:
 - » full load of the site between 50% and 100% of the total battery capacity
 - » critical loads between 30% and 50% of the total battery capacity. During this period non-critical load should be operating exclusively on the supply from the Jamaica Public Services Company Limited (JPSCo)
- complete the design/application process and obtain a net billing license from the JPSCo.
- submit schematic designs and as-built drawings for the installed solar power generation system.

The solar power generation system should also switch to the JPSCo's electrical system during none to low generation periods.
