Gov't to Pursue Initiatives to Reduce Debt – *PM*

the Most Hon. Andrew Holness says the Government will pursue initiatives to reduce the country's debt, while creating an enabling environment for growth.

The Prime Minister was addressing a news conference at the Hyatt Ziva and Zilara Resort in Montego Bay, St. James, on May 18, for the 46th annual meeting of the Board of Governors of the Caribbean Development Bank (CDB).

He noted that the model of using austerity to bring down the debt has resulted in little or no growth, and expressed confidence in the ability of the CDB to lead the way as to how the Caribbean region can treat with its debt.

rewarding countries which have a high debt profile and take on new bold initiatives to preserve the environment. Already there is a mood globally on how you can incentivise countries to adopt policies that are aligned with environmental preservation and managing climate change," Prime Minister Holness said.

He pointed out that the matter of debt for policy swap was raised during a meeting with the Vice President of the World

Bank for Latin America and the Caribbean, Jorge Familiar.

"The level of significance of this is to be determined, but certainly it is worth exploring. We have to explore all options to bring down the debt and to create more space for us to make investments grow," the Prime Minister said.

Jamaica on Course for US\$80M Drawdown

JAMAICA IS on course for a 12th drawdown of US\$80 million from the International Monetary Fund (IMF).

This is consequent on the country meeting all targets under the Extended Fund Facility (EFF) for the December 2015 and March 2016 quarters, which were reviewed by the IMF Staff Mission Team to Jamaica over the past two weeks.

This was disclosed by Mission Head, Dr. Uma Ramakrishnan, who advised that the disbursement of the funds is subject to the approval of the Executive Board which is scheduled to meet in June.

She was speaking at a media briefing at the Ministry of Finance and the Public Service in Kingston on May 20.

Dr. Ramakrishnan says tax revenue targets were met for the first time since the onset of the global finan-

cial crisis in 2007; and the Government's primary surplus for the 2015/16 fiscal year "slightly" exceeded the target for 7.25 per cent of the gross domestic product (GDP).

For his part, Finance Minister, Hon. Audley Shaw, emphasised that the Administration "remains fully committed to the objectives under the EFF-supported reform programme and overall debt reduction in particular."

Jamaica Emerging as Shining Example – CDB President

PRESIDENT OF the Caribbean Development Bank (CDB), Dr. Warren Smith, says Jamaica is emerging as a shining example of a country that has weathered the storm of austerity and is now on the road to economic stability.

Addressing the CDB's 46th annual meeting of Board of Governors at the Montego Bay Convention Centre, Rose Hall, St. James, on May 18, Dr. Smith said there is tangible evidence that Jamaica is turning the corner and is on course for a bright and sustainable future.

"We can take encouragement from the green shoots now beginning to appear, right here in Jamaica," he noted.

Dr. Smith argued that Jamaica's pursuit of eco-

nomic and structural reforms, under the International Monetary Reform Programme, required huge sacrifices by the Jamaican people.

"Many reforms for improving the business climate have been introduced, and many more are underway. Private investment is now beginning to increase, which is evident in the vital tourism and renewable energy sectors. We are also seeing this in business process outsourcing and the local manufacturing sectors," Dr. Smith added.

Drafting of Microcredit Bill Far Advanced

THE DRAFT Microcredit Bill, which aims to create an authority to regulate microfinancing firms, is in an advanced state.

This was disclosed by Minister of Industry, Commerce, Agriculture and Fisheries, Hon. Karl Samuda, at a Microfinance Institutions meeting, held at the Ministry's New Kingston offices on May 18.

He noted that the legislation will assist in the registration of microcredit lending companies that provide financing to the micro, small and mediumsized enterprise (MSME) sector.

The Bill will allow the entities to be licensed, while also providing measures for the protection of consumers.

Mr. Samuda said the Ministry is also finalising with the Ministry of Finance and the Public Service, the offset regulations that will be provided under the Public Procurement Act which was passed in 2015.

"(This) will enable greater participation of the MSME sector in Government contracts," he explained.

Mr. Samuda added that the Government is placing greater focus on the development of the MSME sector, and has set a target of a minimum four per cent growth for the sector this year.
