TENDER FOR ROUTINE MAINTENANCE WORKS: WIRELESS STATION ROAD, ST. ANDREW

The National Works Agency invites eligible contractors to submit tenders for Routine Maintenance Works: Wireless Station Road, St. Andrew. The works include site clearance, drainage improvement works, earth and base works, pothole patching and Asphaltic Concrete overlay to some road sections.

Eligibility: It is mandatory that contractors be on the National Contracts Commission (NCC) List of Registered Contractors at the specified level in any of the following categories for their tenders to be eligible: Grades 1, 2, 3 or 4 in the General Road Works, or Road Surfacing – Asphaltic Concrete Works

Availability: Tender Documents will be made available as of **Wednesday, July 9, 2014**, at the National Works Agency's, Corporate Office, 140 Maxfield Avenue, Kingston 10 in the Directorate of Regional Implementation & Special Projects.

Fee: A non-refundable payment of J\$3,000 in cash or Managers' Cheque, payable to the Chief Executive Officer, National Works Agency, is required for each set of Tender Documents.

Return of Tenders: Completed tenders along with the required documents [National Contract Commission (NCC) Certificate of Registration and a valid Tax Compliance Certificate (TCC), etc.] are to be placed in an envelope labelled "ROUTINE MAINTENANCE WORKS: WIRELESS STATION ROAD, ST. ANDREW." The envelope should then be placed in the Tender Box similarly labelled and located in the Lobby of the National Works Agency, 140 Maxfield Avenue, Kingston 10. Tenders are to be returned no later than 2:00 p.m. on Wednesday, July 23, 2014.

Tender Opening: The Tenders will be opened at **2:15 p.m., July 23, 2014** at the National Works Agency, 140 Maxfield Avenue, Kingston 10. Tenderers or their representatives are invited to the opening.

All queries concerning the Tender Document shall be made in writing and addressed to: Regional Coordinator, National Works Agency, 140 Maxfield Avenue, Kingston 10, by **Wednesday, July 16, 2014.**

Tenders not accompanied by a valid Tax Compliance Certificate (TCC) and NCC Certificate of Registration will be rejected.
