#### REHABILITATION/UPGRADING OF POTABLE WATER DISTRIBUTION NETWORK CONSTRUCTION OF 1.0 KM OF 400 mm (16") NOMINAL DIAMETER PVC PIPELINE ALONG THE SAVANNA-LA-MAR MAIN ROAD

The National Water Commission (NWC), through its Engineering & Project Delivery Department intends to continue the rehabilitation and upgrading work on the potable domestic water supply to our valued customers in communities of Savanna-la-mar and environs.

In this instance, some 1.0 kilometre of a water transmission pipeline is to be upgraded along the Savanna-la-mar main road commencing from a point in the vicinity of Dunbar's Crossing and ending at the Mannings School gate.

The NWC hereby invites Tenders for mains replacement work, from suitable contracting entities currently registered with the National Contracts Commission (NCC) at Grade 2 and above, in the categories of Pipelaying or Civil Engineering Works, for the complete construction, testing and commissioning into service of approximately 1.0 kilometres of 400 mm (16") nominal diameter PVC transmission pipeline; together with numerous appurtenances all of stated **Contract Specification and Conditions**; in particular being able to satisfy the NWC prior to an award, of being capable of effecting specified trench works, of high quality, in the public roadways together with excellent traffic control capabilities.
